Ex-parte Order 01.07.2022

Plaintiff along with counsel present. List of witnesses submitted. Ex-parte evidence of plaintiff recorded as PW-01 to PW-03 and closed. Exparte arguments also heard and record perused.

Brief facts in the backdrop are that plaintiff namely Mohib Ali has filed the instant suit against the defendants Assistant Director, NADRA Orakzai and one other for declaration and permanent injunction to the effect

With due process of law and procedure, the defendants were summoned, they appeared through representative. Authority letter and written statement was filed but later on, he remained absent, therefore, placed and proceeded against ex-parte.

Plaintiff produced three witnesses in support of his claim.

Sabir Ali, Teacher, Government Primary School, Kurez, District Orakzai appeared and deposed as PW-01. He produced Service Book of plaintiff consisting of 09 sheets as Ex. PW-1/1, CNIC exhibited as Ex. PW-1/2.

Syed Nazar, brother of plaintiff appeared and deposed as PW-02. His CNIC exhibited as Ex. PW-2/1. He supported the claim of plaintiff.

Plaintiff himself deposed as PW-03. Copy of his CNIC exhibited as Ex. PW-3/1. He reiterated the averments of plaint. He lastly requested for decree of suit against the defendants as prayed for.

Claim and contention of plaintiff is that as per Service Record, his true and correct date of birth is 1965, however, defendants have incorrectly entered date of birth of plaintiff as 01.01.1962 which is wrong, illegal and ineffective

There is nothing in rebuttal due to ex-parte while plaintiff produced cogent, convincing and reliable documentary as well as oral evidence in support of his claim.
