

SUMMARY JUDGEMENT

19.07.2022

Plaintiff along with counsel present. Representative of
defendants present. Arguments heard and record perused.

Brief facts in the backdrop are that plaintiff has filed the instant
suit for declaration cum-permanent injunction to the effect that, as per
school record, his true and correct date of birth is 01.01.1987, however,
defendants have incorrectly entered the same as 1982 which is wrong,
illegal and ineffective upon the rights of plaintiff and liable to be
rectified. That defendants were asked time and again to rectify date of
birth of plaintiff but in vain hence, the present suit.


was submitted. Written statement was also filed. Notice of summary disposal was given to the parties vide order dated: 04.03.2022.

Statement of Head Teacher namely Gula Jan was recorded as CW-01. Copy of his CNIC is Ex. CW-1/1. He produced register of admission which is Ex. CW-1/2 as per which, date of birth of plaintiff is recorded as 01.01.1987.

Plaintiff has placed reliance on school record. Per school record, date of birth of plaintiff is recorded as 01.01.1987. Representative of defendants stated that date of birth of plaintiff may be modified as per school record per NADRA SOPs. School record of plaintiff is placed on file. Plaintiff shall produce school record before the office of defendants for the modification in date of birth as 01.01.1987. There is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff as 01.01.1987 accordingly. Suit of plaintiff is decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any. This decree shall not affect service record of plaintiff, if any.
