Order.05	31.10.2022	<p>Petitioner present through attorney and counsel.</p> <p>Petitioner's evidence recorded. Argument heard and case file perused.</p> <p>Perusal of case file reveals that the instant petition instituted by the petitioner for appointment as legal guardian for the person and properties of the minors namely 1) <b>Hazrat Ullah s/o Khalil Said, 02), Ihsan Ullah s/o Khalil Said and 03) Sapna Bibi d/o Khalil Said</b> mentioned in the petition on the grounds that the petitioner is the real mother of the minors.</p> <p>The respondent/general public was summoned through publication in newspaper "Daily Ausaf" dated: 27<sup>th</sup> September, 2022, however none turned up as legal guardian of the minors other than the petitioner. Therefore, the respondent proceeded ex-parte. Consequently, petitioner produced ex-parte evidence.</p> <p>At this stage there seems to be no clash of interest between the minors and the petitioner, being a real mother of the minors, in the light of statements of witnesses produced by the petitioner. It is evident that minors are residing presently with the petitioner, who is taking after them. As real mother, she is most likely to take care of the welfare of the minors. Therefore, the petition in hand is accepted under Section-07 of Guardian &amp; Wards Act, 1890 and petitioner is appointed as guardian of the person of the above minors having generally the rights, duties and liabilities of a guardian mentioned in the Guardian &amp; Wards Act, 1890 and subject to the following conditions especially in view of section-34 of the said Act.</p> <ul style="list-style-type: none"><li>• <i>That she will produce the minors in court as and when required by the court.</i></li><li>• <i>That she will maintain and educate the minors in proper manner.</i></li><li>• <i>That she will not take away the minors outside the jurisdiction of this court without prior permission.</i></li></ul>
