Brief facts in the backdrop are that plaintiff has filed the instant suit for declaration cum-permanent injunction to the effect that as per School record and death certificate, correct name of father of plaintiff is **Abdul Jabar**, however, the defendant has incorrectly entered the same as **Syed Lal Jan** which is wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. That defendant was asked time and again to rectify father's name of plaintiff but in vain hence, the present suit.

Plaintiff has annexed with plaint his School Certificate, death certificate of Abdul Jabar (father) and certificate for correction of father's name as per which, father's name of plaintiff is recorded as Abdul Jabar. Defendant has entered father's name of plaintiff as Syed Lal Jan. Son of Syed Lal Jan, in his statement recorded today, supported plea of plaintiff. Defendant is directed to rectify father's name of plaintiff as Abdul Jabar. Suit of plaintiff is decreed as prayed for. No order as to cost.
