**SUIT FOR DECLARATION, CUM PERPETUAL AND
MANDATORY INJUNCTION**

SUMMARY JUDGEMENT:

23.11.2022

1. Brief facts of the case in hand are that the plaintiff, **Shakeel Rehman** has brought the instant suit for declaration cum perpetual and mandatory injunction against the defendants, referred hereinabove, seeking declaration therein that his correct date of birth is **01.04.2006** according to his Provisional Certificate of Matric and Matric DMC and his correct name is Shakeel Rehman (شکیل رحمن), while these have been wrongly mentioned as 01.01.2003 and Shakeel Rahman (شکیل رحمان) respectively in his Form-B by the defendants, which is wrong, ineffective upon the rights of the plaintiff and liable to correction. That the defendants were repeatedly

asked to correct the date of birth and the name of plaintiff but they refused, hence, the instant suit.

2. Defendants were summoned, who appeared through their representative namely Mr. Irfan Hussain, who submitted written statement, whereby it is mentioned that both the name and date of birth of the plaintiff have already been corrected by the defendants and have issued him all the relevant documents concerning the defendants on 17.03.2020. The relevant documents were also annexed with the written statement.

3. During the scheduling conference within the meaning of order IX-A of CPC, it was revealed that the parties are no more at issue as the defendants have already done what is sought for by the plaintiff in his plaint. Today his matriculation documents were compared with the documents in the possession of the defendants, which both bear the same entries.

4. Consequently, upon what has been discussed above and the jurisdiction vested in this court under order IX-A and XV-A of CPC, suit of the plaintiff is hereby **disposed off accordingly**.


