**SUIT FOR DECLARATION, PERMANENT AND MANDATORY INJUNCTION**

**SUMMARY JUDGEMENT:**  
**14.09.2022**

1. Brief facts of the case in hand are that the plaintiffs have brought the instant suit for declaration, permanent and mandatory injunction against the defendants, referred hereinabove, seeking declaration therein that correct dates of birth of the plaintiff no. 1 is **01.07.1980** and that of plaintiff no. 2 is **01.01.1980** while defendants have wrongly entered as 01.07.1983 and 01.01.1985 in their record, which are wrong, ineffective upon the right of the plaintiffs and liable to correction. That the defendants were repeatedly asked to

correct the dates of birth of plaintiffs but they refused, hence, the instant suit.

2. Defendants were summoned, who appeared through their representative, who submitted authority letter and written statement.
3. During the scheduling conference within the meaning of order IX-A of CPC, it was revealed that the matter involved in the instant case is very petty in nature, which can be decided through summary judgement as per relevant record.

To this effect notice was given to the parties that why not the case in hand be decided on the basis of available record without recording lengthy evidence, as the primary aim and

objective of Amended Management Rules in CPC is, "to enable the court to-

- a. Deal with the cases justly and fairly;
- b. Encourage parties to alternate dispute resolution procedure if it considers appropriate;
- c. Save expense and time both of courts and litigants; and
- d. Enforce compliance with provisions of this Code."

Learned counsel for plaintiffs heard and record gone through.

4. Record reveals that plaintiffs through instant suit are seeking correction of dates of birth to the effect that correct dates of birth of plaintiff no. 1 is **01.07.1980** and plaintiff no. 2 is

01.01.1980 while it has been wrongly entered as 01.07.1983 and 01.01.1985 in the CNICs of the plaintiffs by the defendants, which are wrong, ineffective upon the right of the plaintiffs and liable to correction. Plaintiffs in support of their contention produced the copies of CNICs of their children namely Hazrat Ullah, bearing CNIC No. 21604-7369597-7 and Abida Bibi bearing CNIC No. 21604-9387707-2, wherein the dates of birth of plaintiffs children are 20.02.1998 and 14.01.2002, according to that there is a gap of 15 and 17 years between the plaintiff no. 1 and their children whereas, there is a gap of 13 and 15 years between the plaintiff no. 2 and their children which are un-natural and against the SOP of NADRA. The said documents clearly negate the incorporation of dates of birth of plaintiffs as 01.07.1983 and 01.01.1985 in their CNICs. Further, there is no countered document available with the defendants to rebut the documents produced by the plaintiffs in support of their contention. So, the available record clearly establish the claim of the plaintiffs.

5. Consequently, upon what has been discussed above and the jurisdiction vested in this court under order IX-A and XV-A of CPC, suit of the plaintiffs succeeds and is hereby decreed as prayed for. Defendants are directed to correct the dates of birth of plaintiff no. 1 i.e. Muhammad Javid son of Ameen

Shah as **01.07.1980** and that of plaintiff no. 2 i.e. Mst; Dabab Jan wife of Muhammad Javid as **01.01.1980** in their record and in the CNICs of the plaintiffs.

7. File be consigned to the District Record Room, Orakzai after its necessary completion and compilation.


