		Arguments heard and record perused. Perusal of
		the case file shows that though the accused facing trial is
		directly nominated in the FIR but no date, time and place
		of occurrence is known. There is no eyewitness of the
		occurrence and the case of prosecution rests upon the bold
		statements of complainant and his daughter. Furthermore,
		the parties are close relatives and they have patched up
		the matter out of the court. The complainant present
		before the court also raised no objection upon the
		acceptance of application u/s 265-K CrPC.
		In view of what is discussed above, it is held that
		there is no probability of the conviction of accused facing
		trial, even if the charge is framed and the prosecution is
		given opportunity to produce the witnesses; therefore,
