

Order	08.09.2022	<p>Mr. Muhammad Arif Jan Afridi advocate represented accused/petitioner; complainant along with his counsel Sana Ullah Khan Advocate and Mr. Zubair APP for the State are in attendance.</p> <p>2. This is the disposal of Post arrest bail application presented by accused/petitioner Sayed Bar Khan son of Jan Gul, resident of Bara District Khyber.</p> <p>3. Complainant Khan Muhammad son of Abdullah resident of Qaum Feroz Khel Tappa Jaisal Khel District Orakzai, reported against the present accused including 03 other unknown persons with muffled faces for snatching his Pickup vehicle on gunpoint. Consequently, FIR bearing No.68 dated 16-07-2022 was registered at Police Station, Kalaya against accused under section(s) 392/34 of the Pakistan Panel Code-1860. Accused was later on arrested and is behind the bar obliged him to file instant application which is under consideration.</p> <p>4. Arguments of the learned counsel for the accused/petitioner and learned APP for the State assisted by counsel for the complainant heard and record perused.</p> <p>5. The tentative assessment of record reveals that it is daylight occurrence which has promptly been reported but independent witnesses have been associated. The accused was nominated by name with association of three other persons having muffled faces. This means that accused was known to complainant and in this scenario, the accused was supposed to be muffled face. If he was not so, the argument of petitioner regarding the issues of payment seemingly shattered the cover of offence as robbery. The identification parade of the recovered vehicle has not been conducted which is further fact available for rendering the case as that</p>



For what has been discussed above, instant bail petition stands allowed subject to furnishing bail bonds to the tune of Rupees one lac and twenty thousand (120,000/-); with two sureties; each in the like amount; to the satisfaction of this Court.
