such accused. The 04 members Medical Board consisting upon General Surgeon, Medical Specialist, Orthopedic Surgeon and Deputy Hospital Administrator has opined in a report with the name of Assessment Of Medical Board DHQ Hospital Mishti Mela Orakzai dated: 08-09-2022 in following terms;

"After detailed history and examination of patient and assessing his lab results, the medical board came to the conclusion that the patient is suffering from blood disorder that is anemia and B12 deficiency. Chronic anemia can lead to cardiac complications. His mental condition is not stable enough at the moment that may need medical psychiatric opinion or admission in drug rehabilitation center. The patient needs specialized care regarding his health otherwise further jail may adversely affect his general wellbeing and mental condition."

- 6. Correct criteria for grant of bail to an accused in non-bailable case on medical ground is that the sickness or ailment which the accused is suffering is such that it cannot be properly treated within the Jail premises and that some specialized treatment is needed and his continued detention in Jail is likely to effect the capacity or is hazardous to his life (2000 SCMR-107). In instant case, the opinion of medical board constituted for the purpose of examining the accused and his medical documents fulfil the given criteria and thus retaining the accused in prison is seemingly against the very purpose of administration of Justice.
- 7. For what has been discussed above, instant bail petition stands allowed subject to furnishing bail bonds to tune of rupees 60,000/- with one surety; to the satisfaction of this Court. File of this Court be consigned to District Record Room after its necessary completion and compilation within the span allowed for; whereas, copy of this Order be placed on record of Police to be returned accordingly.
