

The one Muhammad Wali (father of Nasreen Bibi) has submitted an application for custody of his daughter namely Mst. Nasreen Bibi who is present in Dar-Ul-Aman, Peshawar.

Perusal of record reveals that the Mst. Nasreen Bibi was arrested by the local police of PS Ghiljo, U/Orakzai through Naqalmad No. 11, Dated: 20.09.2022 and thereafter, she was produced before the JM, Orakzai at Baber Mela on 21.09.2022 wherein, her statement was recorded u/s 164 Cr.P.C and she was sent to Dar-Ul-Aman, Peshawar in police custody in the company of a lady constable.


Today, she was again produced before the court of undersigned upon the instant petition filed by her father. Her statement was once again recorded wherein, she refused to go with her parents present in the court as she feel threatened of them and other relatives.

Thus, in these circumstances the petitioner namely Muhammad Wali is not entitled to the custody of Mst, Nasreen Bibi hence, application in hand is **dismissed**.

Zamima "Bay" stands cancelled. She be sent back to Dar-Ul-Aman, Peshawar in police custody in the company of a lady constable and be produced before the court concerned/MOD on **03.10.2022**.
