



Order No.03</p>	<p align="center">  Shaukat Ahmad District & Sessions Judge Orakzai at Baber Mela 19/09/22 </p>	<p>confirmation of his ad-interim pre-arrest bail in case FIR no. 13, dated 06.05.2022, u/s 324/148/149 PPC of PS Dabori wherein, as per contents of FIR, on 06.05.2022 the local police acting on information regarding the occurrence, reached civil hospital where complainant/injured Fazal Rehman made a report to the police to the fact that on day he along with Muhammad Imran while on way to Dabori Bazar via motorcycle, when reached the place of occurrence, Muhammad Hussain (accused/petitioner) along with Khialdad Khan, Rifat Ullah, Sher Khan and Ezat Khan attacked them with sticks and hurled stones at them. Meanwhile, the present accused/petitioner started firing at them, as a result of which the complainant got hit on his right leg while Muhammad Imran luckily escaped unhurt. Hence, the present FIR.</p> <p>At the very outset, complainant and Muhammad Imran submitted a compromise deed dated 12.09.2022 and stated at the bar that they have patched up the matter with the accused/petitioner, forgiven the accused in the name of Almighty Allah and that they have got no objection on confirmation of the Bail Before Arrest of the accused/petitioner or his acquittal.
