		his home forcibly and now she is residing with her parents,
		that the minors were retained by the respondent who cannot
		take care of the minors being irrelevant, that all of the
		minors are of tender age and retaining such children from
		the mother is a cruel act of the respondent. The petitioner
		submitted in her application that all the minors may be recovered and may be handed over to the petitioner.
		3. The contention of the petitioner was deemed
		genuine; therefore, the bailiff was directed to visit the
		house of respondent and produce the minors named above
		before the court. Today, the process server produced the
		minors before the court and both the parties also appeared
		before the court in persons.
		4. The respondent stated before the court that the
		petitioner left her home with her free will and consent and
		also left the minors with him. The respondent further stated

		if the minors are handed over to petitioner being mother of
		the minors and stated that the petitioner shall be responsible to take proper care of the minors. Lap of the mother is a

heavenly place and she has inherent right to keep her children close to her bosom and rear them up under her umbrella (2009 YLR 1678). Therefore keeping in view the stance of respondent and age of all the minors who needs proper care and love of their mother, the minors namely Mst Samrina Bibi, Mst Umaira Bibi and Naeem Khan are handed over to the petitioner in the court. The petitioner was directed to submit surety bond in the sum of Rs. 100,000/- to the effect that when the minors are required to the court the petitioner shall produce them which she submitted and placed on file. The respondent is at liberty to knock the door of competent jurisdiction for the proper custody of minors and the custody of minors may be decided in accordance with law keeping in view the welfare of minors.

- 5. In view of the above discussion the petition in hand is disposed of accordingly.
