Order No.1	27.09.2022	<p>Case file received from the court of learned CJ-I/Judicial Magistrate, Kalaya after recording evidence u/s 512 Cr.P.C. Register.</p> <p>Accused, (1) Ameer Muhammad s/o Khan Faqir and Raees Khan, both residents of caste Bar Qambar Khel are charged in case FIR no. 20, dated 07.09.2021, u/s 9 (d) of the Khyber Pakhtunkhwa CNSA and 324/186/468/471/34 PPC of PS Kurez Boya wherein, as per contents of FIR, the local police acting on information regarding smuggling of chars by the above-named accused via motorcar no. IDG6525/Islamabad, laid a picket on the spot where at about 0230 hours a motorcar came on the spot boarded by a driver and a person wearing veil, which was signaled to stop but the driver of the motorcar by ignoring the signal made their escape good and abandoned the motorcar, the search of which led the complainant to the recovery of 15 packets of chars, each weighing 1000 grams (total 15000 grams).</p> <p>The accused despite proceedings u/s 204 Cr.P.C as well as u/s 87 Cr.P.C failed to appear. Hence, they were proceeded u/s 512 Cr.P.C. The court of learned CJ-I/Judicial Magistrate, Kalaya recorded the statements of as many as four (04) PWs and sent the file to this court for further proceedings.</p>
