Brief facts in the backdrop are that plaintiff Seemal Din has

the defendants Chairman NADRA, Islamabad and two others to the

effect that correct name of his father is Zarab Din and CNIC number of his father is 21603-2661512-7 and his correct mother's name is Bibi Zarkhela, however, defendants have incorrectly entered CNIC number of his uncle namely Zarab Din (CNIC No. 21603-0217174-5) in the official record and his mother's name is recorded as Gul Sanga instead of Bibi Zarkhela which entries are wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. That defendants were asked time and again to rectify the record but in vain

With due process of law and procedure, the defendants were summoned, they appeared through representative. Authority letter was submitted. Written statement was also filed.

hence, the present suit.

Representative of defendants produced NADRA record as per which father's name of plaintiff is correctly recorded as Zarab Din but instead of CNIC number (21603-3550964-3) of his father (Zarab Din), CNIC number (21603-0217174-5) of his uncle namely Sharab Din is entered. Similarly, mother's name of plaintiff is recorded as Gul Sanga instead of Bibi Zarkhela. As per record produced by representative of defendants, Zarab Din is the husband of Bibi Zarkhela and Sharab Din is the husband of Gul Sanga which shows that Zarab Din and Bibi Zarkhela are parents of plaintiff and Sharab Kalaya Orakzai Din and Gul Sanga are uncle and aunt of plaintiff. Therefore, there is no need of recording evidence of parties. Representative of defendants

stated that per NADRA SOPs, the modification/rectification sought by

plaintiff could be made accordingly. Suit of plaintiff is hereby decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any. This decree shall not affect service record of plaintiff, if any.
