**SUMMARY JUDGEMENT**

04.03.2024

Plaintiff present through counsel. Legal representative of  
defendants No. 1 to 3 present. Defendant No. 4 has already been  
placed and proceeded ex-parte. Counsel for plaintiff requested for  
summary disposal of the case on the basis of available record.  
Representative for contesting defendants conceded the same.

Arguments heard and record perused.

Brief facts in the backdrop are that plaintiff Simra Zahra has  
filed the instant suit for declaration cum-permanent injunction against  
the defendants Chairman NADRA, Islamabad and three others



through father to the effect that, as per school record and domicile certificate, true and correct date of birth of plaintiff is **01.02.2011**, however, defendants have incorrectly entered the same as **01.02.2008** in her form-B and Birth Registration Certificate which entries are wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. That defendants were asked time and again to rectify date of birth of plaintiff but in vain hence, the present suit.

With due process of law and procedure, the defendants were summoned, out of whom defendant No. 1 to 3 appeared through legal representative. Authority letter was submitted. Written statement was also filed. Defendant No. 4 remained absent despite service, therefore, placed and proceeded against ex-parte.

Record shows that plaintiff has placed reliance on school record and domicile certificate. Per school record and domicile certificate, date of birth of plaintiff is recorded as 01.02.2011. Representative of contesting defendants stated that date of birth of plaintiff may be modified/rectified as per school record and domicile certificate per NADRA SOPs. Copy of school certificate and domicile certificate of plaintiff are annexed with plaint. Defendant No. 4 did not contest the suit. There is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff as **01.02.2011** accordingly. Suit of plaintiff is decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any.


