no objection if the Court discharge or release the accused.

- 5. Today the counsel for accused present before the court stated at the bar that the accused and complainant party had patched up the matter and assure the Court that they will not interfere in the marriage/Nikah of the sister of complainant and the complainant is at liberty to contract the marriage of his sister according to his own will and consent. The complainant who is also present before the court recorded his statement that I have patched up the matter with accused and accused is not interfering in the contract of marriage of his sister and he has got no objection on the acquittal/discharge of the accused in instant case and thumb impressed on his statement.
- 6. For what has been discussed above, the application submitted by the prosecution for the withdrawal of instant case is accepted. Consequently, the accused namely Piyao Gul is acquitted in instant case from the charges levelled against him as prosecution has withdrawn from it.
- 7. The accused is on bail, his sureties are released from the liability of bail bonds. File of this Court be consigned to District Record Room after its necessary completion and compilation within the span allowed for.
