have been provided time to compromise. On lapse of sufficient time, the parties failed to patch up the matter and therefore proceeded under Section-107 of the Code of Criminal Procedure, 1898. Admittedly, allegations of clash followed by injuries which have medically assessed constitute commission of cognizable offense calling for registration of FIR by the Police. In case of failure on part of Police to perform its duty, this Court is empowered to issue appropriate directions to the Police on complaint regarding non-registration of Criminal Case. Resolution of controversies does not fall within the ambit of investigation and the same cannot be based for non-registration of case.

5. For what has been discussed above, the petition stands allowed. Consequently, SHO of Police Station Mishti Mela is directed to register report of the petitioner under the relevant provision of law and to proceed further in accordance with law. File be consigned to District Record Room after necessary completion and compilation within span allowed for.
