

Order No. 13	19.12.2022	<p>Accused namely Abdul Haleem s/o Muhammad Saeed charged in case FIR No. 05, Dated: 13.02.2022, registered U/S 11(A)CNSA at police station Dabori, U/Orakzai appeared in person.</p> <p>DPP for the state present.</p> <p>Accused submitted an application for disposal of case wherein pleading his guilt. He waived his right U/S 241-A Cr.P.C willfully. Notice u/s 243 Cr.P.C given to the accused in response of which he placed himself at the mercy of the court.</p> <p>As the accused pleaded his guilt and has prayed for mercy of the court. Therefore, keeping in view the plea of guilt of the accused and while taking lenient view accused is convicted under section 11A(CNSA) and sentenced to simple imprisonment for 22-days and fine of Rs. 300,000/- and in default of the payment of fine he will have to undergo simple imprisonment for 10 days more.</p> <p><i>Continue</i></p>
