Learned APP for the state present. Accused Sinjab Ali, Dilshad Ali and Sahib Ali on bail present.

The accused submitted an application for pleading their guilt and requested for decision of their fate in the case on the basis of their plead guilty. Formal charge already framed and evidence of prosecution already recorded. Accused pleaded their guilt and placed their selves at mercy of the court.

Thus, on the basis of their plead guilty, the accused are hereby convicted for commission of the offence U/S 15AA. Keeping in view the whole-hearted plea of their guilt and their previous non-involvement in any such or any other criminal activity on their side, accused are sentenced to three years each simple imprisonment and fine of Rs. 1,000/- each for section 15AA. In default of payment of the fine, accused shall undergo three days simple imprisonment.



There is nothing on record which could show previous involvement of accused in such like cases, therefore, the sentence ibid is suspended and converted into probation and they are placed on

probation for the above period under the Probation Ordinance. They shall remain under the supervision of the Probation Officer (male) for the above-mentioned period subject to furnishing bail bonds in the sum of Rs. 50,000/- with two local and reliable sureties, to the satisfaction of probation officer (male) Orakzai, with the following conditions.

1. That they shall not repeat the offence.
2. That they shall keep and maintain peace and order in the society.
3. That they must exhibit good behavior during the prescribed period of probation.
4. That they shall appear before the probation officer once in a month, which date is left to the discretion of the probation officer to be fixed.
5. That they shall not leave the country without permission of probation officer.
6. That if they violate the above conditions, the bonds will be recalled and they will be proceeded in accordance with the provision of the Ordinance *ibid*.
7. That in case of default by the convict, the direction regarding probation shall stand recalled and convict shall undergo imprisonment accordingly.
