After submission of complete and supplementary challan against the accused/petitioners, accused were summoned. They appeared and provisions of Section 241-A Cr. PC were complied with. Complainant was also summoned but he did not appear before the court despite repeated summons/notices and warrant of arrest.

Complainant has already affected compromise with accused/petitioners at bail stage. Attested record produced today and record placed on file, shows that complainant namely Jalal Khan appeared before the court concerned and recorded his statement wherein, he stated that he has entered into compromise with accused/petitioners. He has forgiven the accused/petitioners and has got no

objection upon their acquittal at the time of trial. Compromise deed was ZAHIR KHAN Civil Judge/JM Kalaya Orakzai exhibited as Ex. PA while copy of his CNIC was exhibited as Ex. PA/1.

Furthermore, accused Muhammad Sadeeq has already been placed in column No. 2 of challan form due to deficient evidence against him.
