Orakzai is seeking his post arrest bail in case F.I.R No.53 Dated: 24.12.2023 U/S 11ACNSA/15-AA, Police Station Kuriz Boya, District Orakzai.

- 2. Perusal of record would reveal that offence with which accused/petitioner is charged do not fall within the ambit of prohibitory clause of section 497 Cr. PC. In such like cases grant of bail is a rule and refusal are an exception. No extra ordinary circumstances are available on record for refusing bail of accused/petitioner. Accused/petitioner has not confessed his guilt before the court. Investigation has already been completed and accused/petitioner is no more required to the local police for further investigation and no useful purpose would be served by keeping the accused/petitioner behind the bar.
- 3. Consequently, application in hand is allowed. Petitioner be released on bail subject to furnishing bail bonds in the sum of Rs. 100,000/- (One lac rupees) with two sureties each in the like amount to the satisfaction of this court. Copy of this order be placed on police as well as judicial record. The requisitioned record be sent back to the quarter concerned forthwith, while files of this court be consigned to record room after necessary completion and compilation.
