Order 04	23.02.2024	<p>Parties present.</p> <p>Vide this order I intend to dispose of instant contempt of court application filed by Qabil Noor and others, hereinafter referred as petitioners.</p> <p>Arguments already heard and record perused.</p> <p>Now on perusal of the record and valuable assistances of both the learned counsels for the parties, this court is of the humble view that petitioners through instant contempt of court petition have alleged that previously this court vide order dated: 09.06.2023 had granted temporary injunction in their favour for statutory period of six months and had restrained respondents from interfering with the suit property. They further allege that on 03.12.2023 at about 12:30PM one Jamshaid ploughed the suit property through tractor in presence of Imran and Muhammad Hayat and thus violated the orders of this court. Contrary to this the respondents allege that had not violated the orders of this court rather as per order dated: 09.06.2023 they had been permitted by this court to cultivate their own land measuring 25 Jareeb. In given circumstances this court is of the view that perusal of order no. 10 dated: 09.06.2023 would reveal that this court while granting temporary injunction in favour of petitioners had also allowed the respondents to use their own 25 Jareeb property, other than suit property. It is also pertinent to mention here that from the bailiff report it is not clear that the respondents have interfered in the suit property or in their own property. Furthermore, from perusal of the instant contempt of court petition it is evident that the main role of interference and violation of court orders has been attributed to one</p>


