- 1. Petitioner Mst. Nazar Khela widow of Daryab Khan R/O of Qoum Ali Khel, Tappa Aimal Khan Khel, Tehsil Upper, District Orakzai, being real mother, have filed the instant petition for her appointment as Guardian for her children/minors namely Muhammad Javid aged about 15 years and Ajida aged about 11 years. According to petitioner, the above-named minors are residing with her and she being real mother is natural guardian of the minors. That in absence of father of the minors, she is entitled for her appointment as guardian of the minors as she can take better care of the welfare of the minors than any other person.
