



Order 07	18.03.2024	<p>APP for the state present. Accused Shafique produced from judicial lock-up. PW Nasir Khan present. Today the case in hand was fixed for prosecution evidence, however at the very out set accused facing trial stated at the bar that he want to confess his guilt in the instant case and in this respect he also submitted an application for plead guilty, which is placed on file.</p> <p>2. Brief facts of the case are that as per version of the complainant in the FIR, on 03.11.2023 at about 14:30hrs complainant was on routine patrolling when they saw a person holding blue plastic shopper in his right hand, who was engaged and upon inquiry he disclosed his name as Shafique. Upon search of plastic shopper two hand grenades were recovered from the same, which were taken in to possession and BDS staff was informed accordingly and accused was charged for the commission of offence.</p> <p>3. Complete challan against the accused was put in court on 20.12.2023 and after 241-A Cr.P.C proceedings, the accused facing trial was formally charge sheeted on 06.02.2024. Initially accused pleaded not guilty and claimed trial. However today he filed an application for pleading his guilt and requested for lenient view. After pleading his guilt, show cause notice under section 243 Cr.P.C. was given to the accused as to why he should not be convicted. Resultantly, he prayed for lenient view while placing himself at the mercy of this court.</p>

It is also pertinent to mention here that there is nothing such available on the record which could suggest that accused facing trial is member of any terrorist organization. There is no criminal history of the accused.</p> <p>5. Keeping in mind the wholehearted confession of guilt by the accused and being a first offender, a lenient view is taken and accused facing trial is convicted and sentenced for offence under section 5 Explosive Substances Act, 2013 with simple imprisonment of 05 months. Benefit of 382-B Cr.P.C. is extended to the accused. As for as forfeiture of property of convict/accused to the government is concerned, per record there is no personal property in the name of accused. Accused is young man, poor and jobless person. Case property be dealt in accordance with law.
