

Order 05	19.03.2024	<p>Parties present.</p> <p>Vide this order I intend to dispose of instant application for grant of temporary injunction filed by plaintiff, hereinafter referred as the petitioner.</p> <p>Arguments already heard and record perused.</p> <p>Now on perusal of the record and valuable assistances of both the learned counsels for the parties, this court is of the humble view that petitioner through instant suit allege that suit property is in his possession since the time of his predecessors and thus the respondents have got no concern with the same. Contrary to this the respondents allege that suit property being their ancestral property is their sole ownership and thus the petitioner has got no concern with the same rather he is stranger to the suit property. In given circumstances this court is of the view that there is no revenue record in district Orakzai and thus in absence of revenue record it is not possible for this court to ascertain as to who is the real owner of the suit property and further who amongst the parties has got a prima facie case in his favour rather same would be proved after recording of pro and contra evidence at later stage. However, in order to preserve the suit property during pendency of instant suit and further to avoid multiplicity and complexity of litigation at later stage, this court deed it appropriate to grant temporary injunction in favour of petitioner to the extent of further alienation.</p> <p>In light of above discussion, instant application for grant of temporary injunction filed by plaintiff is hereby allowed and temporary injunction for the statutory period of 06 months or till disposal of the instant suit, whichever comes</p>
