They all were shifted to Kalaya hospital by the people of locality. The motive was stated to be the previous blood feud enmity between the parties. The accused despite being proceeded u/s 204 Cr.P.C as well as u/s 87 Cr.P.C, failed to appear before the court. Hence, they were proceeded u/s 512 Cr.P.C.
