- (2). Comments of the concerned SHO were called, who accordingly submitted his report.
- (3). As per contents of petition, the report of the petitioner constitutes a cognizable offence; therefore, as per law on the point on report of the matter to police, the SHO concerned is bound to enter the substance of the matter on the roll of prescribed register u/s 154 Cr.P.C and proceed to investigate the matter u/s 156 Cr.P.C.
- (4). In these circumstances, petition in hand is accepted.
  SHO concerned is directed to register the FIR. Needless to
  mention that, in case the report of the petitioner was found false, he may be proceeded against in accordance with law.
