is duly thumb impressed by them. Original compromise deed produced which is Ex.PA. Copy of CNIC of special attorney for plaintiff is Ex. PK. Copy of CNIC of defendant is Ex. PB. Copy of CNICs of elders/jirga members are Ex.PC and Ex.PD. Special power of attorney is Ex. PZ.

Brief facts of the case in hand are that plaintiff namely Mst. Zartaj Bibi has filed the instant suit against the defendant namely Ali Khan for declaration- cum permanent injunction and possession through partition to the effect that suit property fully detailed in the head note of the plaint through boundaries is the ancestral ownership of the parties. Plaintiff being daughter of deceased Ali Jan is legally entitled to her shari share in the legacy left by deceased Ali Jan. That defendant is reluctant to give plaintiff her shari share in the legacy evolved upon them after death of their predecessor. That defendant was asked time and again to admit the legal claim of plaintiff but in vain, hence, the present suit.


