Accused/petitioner on ad-interim pre-arrest bail present.

Counsel for accused/petitioner and Razmeen Khan, the victim party, in person are present.

Accused/petitioner Armanullah S/o Minawar Khan seeks confirmation of his pre-arrest bail provisionally granted to him in case FIR no. 27 dated: 13.04.2024 under Section 324/34 PPC of Kurez Boya Police Station, Orakzai.

On 17.05.2024, Izlaf Khan, complainant, appeared before the court and brought into the notice of court that matter has been patched up between the parties and they have got no objection on confirmation of bail before arrest of accused/petitioner and later on acquittal of accused/petitioner and co-accused Rizwanullah at trial stage. Today, Razmeen Khan, father of complainant, also in person present and at the very outset stated at the bar that he has effected compromise with the accused/petitioner and has got no objection on confirmation of bail before arrest of accused/petitioner and later on acquittal of accused/petitioner and co-accused Rizwanullah at trial stage. In this respect the statement of complainant was recorded on 17.05.2024 and that of Razmeen Khan was recorded today, wherein, endorsed that they have effected compromise with accused/petitioner and co-accused Rizwanullah and pardoned them unconditionally by waiving off their legal right of arsh, daman etc. and have got no objection on confirmation of bail



before arrest of accused/petitioner or later on acquittal of accused/petitioner and co-accused Rizwanullah at trial stage. They submitted copies of their CNICs, which are Ex.PB and Ex.PC. Complainant and his father were interviewed about the compromise, who stated at the bar that they have compounded the offence with their free will/consent and without any duress/pressure.

Perusal of record reveals that accused/petitioner stands charged under section 324/34 PPC, which is compoundable offence and since compromise is in the best interest of the parties, hence, the same is accepted and in the given circumstances sending the accused/petitioner behind the bars would serve no useful purpose as he has already joined the investigation, therefore, on the acceptance of compromise in hands, bail before arrest of the accused/petitioner Armanullah is confirmed on the existing bail bonds. The matter of acquittal of accused/petitioner and co-accused Rizwanullah shall be dealt with in accordance with law by the concerned learned trial court on submission of complete challan for trial. Copy of this order be placed on judicial/police files for record.
