**SUIT FOR DECLARATION-CUM-PERPETUAL AND  
MANDATORY INJUNCTION**

**EX-PARTE JUDGEMENT:**

18.05.2024

1. Plaintiff Muhammad Haroon Shah S/O Kamil Badshah R/O Qaum Biland Khel, Tappa Piran, Baza Kalay, Tehsil Ismailzai, District Orakzai has brought the instant suit against Chariman BISE, Peshawar for declaration-cum-perpetual and mandatory injunctions to the effect that his correct name as per CNIC, service record, school records and birth certificate is Muhammad Haroon Shah S/O Kamil Badshah, but the same has been wrongly entered in his record with the defendants as Haroon Badshah which needs rectification. The plaintiff alleged that apart from CNIC, service record, academic record and birth certificate, he also issued publication on 01.08.2003 to the effect that his correct name is Muhammad Haroon Shah. The defendants were asked time and again to make the requisite correction, but they refused and hence the instant suit.

2. Defendants were summoned, who was placed and proceeded ex-parte and the plaintiff was asked to produce his ex-parte evidence. The plaintiff recorded his own statement as PW-01. He produced his CNIC, copy of which is Ex. PW-1/1, Copy of school leaving certificate of the Government Primary School No. 2, Biland Khel is Ex. PW-1/2, copy of birth certificate issued by the Government Primary School, Biland Khel No. 2 is Ex. PW-1/3, service book is Ex. PW-1/4, publication issued in Daily Mashriq is Ex. PW-1/5, DMC of Secondary School Certificate examination issued by BISE, Peshawar is Ex. PW-1/6 and certificate of SSC issued by BISE, Peshawar is Ex. PW-1/7.

3. PW-02, Hizbullah Shah S/O Abdullah Shah stated that plaintiff is his nephew and his correct name is Muhammad Haroon Shah. He is serving as Class-IV at Government High School, Biland Khel. CNIC of PW-02 is Ex. PW-2/1.

4. After closing of evidence, arguments heard and available record perused which shows that plaintiff on 05.03.2024, has preferred an application to the Controller of Examination, BISE, Peshawar, wherein he requested for correction of his name. The plaintiff produced his CNIC Ex. PW-1/1, School leaving certificate Ex. PW-1/2, Birth certificate Ex. PW-1/3, Service record Ex. PW-1/4 and Publication wherein he has categorically mentioned that his correct name is Muhammad Haroon Shah. All the documents from Ex. PW-1/1 to Ex. PW-

1/4 also clearly shows his name as Muhammad Haroon Shah, but the same has been wrongly entered in his record with the defendants i.e., Ex. PW-1/6 & Ex. PW-1/7 as Haroon Badshah which is liable to correction. There is nothing in rebuttal due to ex-parte against defendants. Furthermore, it will not affect the right of any third person, if the required correction is made, therefore, I hereby issued ex-parte decree in favour of the plaintiff against the defendant as prayed for. No order as to cost.
