DyPP for the state present. Accused Hakeem Gul on bail and present while accused Majeed Gul, Muhammad Tariq, Sajid Ullah, Muhammad Ullah, Abdul Samad, Safi Ullah, Mst Niaz Bibi and Mst. Safar Jan on bail are exempted. Complainant Abdul Salam along with Syed Salam injured and Umar Gula injured present. On 09.05.2024, statement of injured Abdul Basit was recorded to the effect that he has effected compromise with the accused facing trial and have pardoned them in the name of Almighty Allah. Joint statement of Abdul Salam, Syed Salam, Umar Gula recorded while statement of injured Muhammad Yaseen recorded through WhatsApp. They stated that they have patched up the matter with the accused facing trial with the intervention of elders of locality and they have pardoned the accused nominated in mad No. 6 of the case FIR No. 12 dated: 28.04.2022 U/S 324/148/149, PS Dabori in the name of Almighty Allah and have got no objection if the accused are acquitted from the charges levelled against them. All the above-named injured persons also waived off their right of Arsh/Daman under the law. Photocopies of CNICs of



Injured Abdul Basit, complainant Abdul Salam, injured Syed Salam, injured Umar Gula and WhatsApp screenshot of injured Muhammad Yaseen are Ex. PA, Ex. PC to PF respectively, while compromise deed is Ex. PB. Complainant party duly thumb impressed their statements.

Offences are compoundable and the compromise being genuine, therefore, all the above mentioned accused on bail nominated in the FIR are acquitted from the charges levelled against them on the sole ground of compromise in the above-mentioned Mad. Accused Hakeem Gul, Majeed Gul, Muhammad Tariq, Sajid Ullah, Muhammad Ullah, Abdul Samad, Safi Ullah, Mst Niaz Bibi and Mst. Safar Jan are on bail. Their sureties are discharged from the liabilities of the bail bonds. Case property, if any, be dealt with in accordance with law.
