**SUMMARY JUDGEMENT:**

1. Plaintiff Azeem Ali S/O Khwag Meen Ali has brought the instant suit against defendant Assistant Director and 01 other for declaration-cum-perpetual and mandatory injunction to the effect that correct name of plaintiff as per Form B and Matriculation is Azeem Ali, while the same has been entered in his record with the defendants as Azeem Khan which is wrong, illegal and liable to correction. He alleged that the defendants were asked time and again for correction, but they refused to do

hence, the present suit;

2. Defendants were summoned, who in their written statement denied the plea of plaintiff.
