Today the case in hand was fixed for case management and scheduling conference and submission of pro-forma E by plaintiff but today once again plaintiff sought time for submission of the same. Perusal of pervious order sheets would reveal that the case in hand is fixed for Case Management and Scheduling conference since 17.02.2024. It is also pertinent to mention here that defendant no.1 had submitted prescribed pro-forma on 09.03.2024 while plaintiff sought time for the same. In this regard five adjournments were granted to the plaintiff for submission of pro-forma E and further costs of Rs-2000/- was also imposed upon him but despite affording sufficient time and proper opportunities plaintiff failed to submit the prescribed pro-forma. It is also worth mentioning here that as per Rule 3 of Order IX-A C.P.C. a seven day prior notice is to be served upon the parties regarding agenda items of conference and thus this court also served the mandatory notice upon both the parties and further directed the parties to ensure their attendance as well as attendance of their counsels on the date fixed. Furthermore, after submission of pleadings by the parties this court is bound by law to conduct case management and scheduling conference within seven days, so as to save the time of parties as well as court and further to ensure speedy disposal of cases. It is also pertinent to mention here that under Rule 6 of Order IX-A C.P.C. this court shall impose penalty upon the party, who or his counsel fails to appear in case management and scheduling conference or is substantially unprepared to participate or does not
