


<p>Order No. 02 Continue..</p>	<p>29.06.2024</p> <p><i>Docel</i> 29.6.24</p> <p><b>BAKHT ZADA</b> Senior Civil Judge/JM Orakzai at Baber Mela</p>	<p>while the present petitioner namely Gul Akbar remained absent and my learned predecessor in office vide his order sheet No. 04, dated 14.12.2022 directed the concerned authorities to block CNIC No. 21601-5399756-1 of surety/petitioner Gul Akbar and hence the instant petition submitted by petitioner Gul Akbar for unblocking his CNIC.</p> <p>The perusal of record shows that the accused namely Jamshed Khan has already appeared before the court and during trial, he was released on probation by Civil Judge/JM-I, Orakzai at baber mela vide his judgement and order dated 12.12.2023. The present petitioner stood surety for the accused Jamshed Khan who is real son of the petitioner and after completion of proceedings under Section 514 Cr. PC against the sureties, the accused has appeared and has faced the trial. The present petitioner being father of the accused has stood as surety for him only on the ground of relation and there is no prospect of any monetary or other benefit on the part of the petitioner. CNIC is the basic need nowadays and no one can be deprived of his fundamental right under the constitution. The proceedings U/S 512 Cr. PC and trial of the accused in the instant case has already reached to its logical conclusion and now keep blocking the CNIC of the petitioner will serve no useful purpose, therefore, I accept the instant</p>
