SYED ABAAS BLUKHARI Civil Judgel Jilli-II Tehsil Courts Kalaya bustle one Hazrat Ullah s/o Badshah Hussain fired at police party but luckily no one got injured. After firing the accused disappeared in mob and further the mob also managed to release the person from the official vehicle. Thereafter police party came back to PS. Meanwhile the tribe men in shape of procession came towards police station and blocked the main road for any sort of traffic. Said procession was being led by the accused nominated in the FIR. The main gate of police station was locked by police party but the mob used abusive language and further threw stones at police station due to which main gate of police station and other articles mentioned in the FIR were damaged.

It is also pertinent to mention here that at bail stage BBA of the accused was confirmed on the basis of compromise between the parties and furthermore, complainant appered before the court and submitted compromise deed, wherein it was mentioned that as per instructions of DPO and with the intervention of elders of locality he has patched up the matter with the accused, hence he has got no objection if the accused are released on bail or subsequently acquitted during trial at later stage.

It is also worth mentioning here that today complainant Younas Khan SHO PS Mishti Mela appeared before the court and stated at the bar that he is no more interested to pursue the instant case as he has previously patched up the matter with the accused. To this effect his statement was recorded wherein the attested copy of compromise deed was exhibited as Ex-PA while copy of his CNIC was exhibited as Ex-PB.

It is also pertinent to mention here that apart from the

compromise previously effected between parties to the instant case, there is also no such conclusive evidence or material available on the record which could lead to the conviction of accused at later stage. No specific role has been attributed to any accused except attributing role of firing to accused Hazart Ullah but neither the weapon of offence has been recovered from accused Hazrat Ullah nor any empties have been recovered from the spot or have been shown in the site plan. There is also no such evidence available on the record that the distribution of flour was actually in progress and furthermore, under what scheme said distribution was being conducted. No source of satisfaction has been disclosed by complainant for charging 46 accused in the FIR and furthermore, how he mentioned the names of accused as well as their parentage in the FIR. Whether all the accused were previously known to him or he implicated them in the instant case. Moreover, the alleged occurrence took place on 27.03.2023 while FIR was chalked on 04.06.2023 i.e. after about more than two months of the alleged occurrence. Furthermore, no reason for such a long delay has been disclosed by prosecution during arguments.

Hence, in the light of the above discussion the application in hand filed under section 249-A Cr.P.C. is hereby accepted and the accused facing trail namely 1. Shabir Khan s/o Minab Khan, 2. Mustaqeem s/o Aisar Khan, 3. Hazrat Ullah s/o Badshah Hussain, 4. Behrain s/o Khan Muhammad; 5. Shahid s/o Hanif, 6. Dilnawaz s/o Gulistan, 7. Raheem Ullah s/o Itbar Khan, 8.
