Petitioner through counsel present. Arguments heard and record perused.

1. Petitioner Sajida Bibi widow of Aman Ullah, R/O Qaum Sheikhan, Tappa Bazid Khel, Tehsil Central, District Orakzai, being real mother has filed the instant petition for her appointment as Guardian for her children/minor namely *1. Fozia Bibi* aged about 12 years *2. Mohsin Khan* aged about 10 years, *3. Muhammad Asif* aged about 8 years and *4. Muhammad Atif* aged about 5 years. According to petitioner, the above-named minors are residing with her and she being real mother is natural guardian of the minors. That in absence of father of the minors, she is entitled for her appointment as their guardian as she can take better care of the welfare of the minors than any other person.

2. Notice to respondents i.e., public at large was issued in daily newspaper "Ausaf" dated 01.04.2024, but no one appeared before the court, so ex-parte proceedings were initiated. During ex-parte vidence, Waheed Ullah as special attorney appeared as PW-01. Hee produced the following documents.

- That she will not take away the minor outside the jurisdiction of this court without prior permission.
- That she will not act in prejudice to the interest of minor.
- That she will not be entitled to dispose of the property of minor without prior permission of the court.

Petitioner has not submitted blank stamp paper and surety bonds,

thus Original guardianship certificate be given to the petitioner subject to produce the blank stamp paper and surety bonds in the sum of Rs. 200,000/- with two local and reliable sureties each in the like amount
