
ORDER

The petitioner seeks registration of FIR against respondent no. 2 for the allegations that the petitioner has given his agricultural land to one, Muhammad Shafiq on *ijara* upon which different kinds of trees are standing and respondent no. 2 have illegally cut few trees and have taken it. The petitioner, for redressal of his grievance, approached respondent no. 1 but in vain; hence, the present petition.

(2). The SHO concerned was directed to furnish his comments which he accordingly did. Placed on file.

(3). Arguments heard and record gone through.


(4). Without touching the merits of the matter, the law on the point is that matter constituting a cognizable offence is

whenever reported to a police, the SHO concerned is bound to enter the substance of the matter on the roll of prescribed register u/s 154 Cr.P.C and proceed to investigate the matter u/s 156 Cr.P.C but in the instant case the contents of petition do not constitute any cognizable offence rather its case of civil nature involving a property belonging to the petitioner and his uncle for which respondent no. 2 has paid the petitioner's uncle a Rs. 6000/-.

- (4). In these circumstances, the petition in hand is turned down. Needless to mention that, the petitioner may approach the concerned forum for redressal of his grievance. Order announced. File be consigned to record room after its necessary completion and compilation.


