Record received.</p> <p>Perusal of the case file reveals that the accused/petitioner is charged u/s 489-F PPC in case FIR No. 86, Dated 08.09.2022 registered at Police Station Kalaya. The accused/petitioner's request for bail was previously denied by learned Judicial Magistrate and subsequently by learned Additional Sessions Judge, Orakzai. The accused/petitioner has submitted a fresh bail petition with the undersigned on the basis of compromise; however, as section 489-F is exclusively triable by Judicial Magistrate and the bail petition was not filed before the Judicial Magistrate which is proper forum.</p> <p>Thus, without addressing the merits of the case, the bail petition is dismissed for, being submitted to the undersigned prior to its submission before the Judicial Magistrate. Needless to mention here that the accused/petitioner may approach the proper forum for filing his bail petition.</p> <p>Record be returned.
