Upon search of the said sack the complainant recovered 10 packets of chars wrapped with yellow color scotch tape, each weighing 1000 grams, making a total of 10000 grams of chars. The complainant separated 10 grams of chars from each packet for chemical analysis through FSL, sealed the same into parcels no. 1 to 10 whereas the remaining quantity of chars weighing 9900 grams sealed in parcel no. 11 while the empty bag weighing 44 grams sealed in parcel no. 12. The spot proceedings were captured through cellular phone which was converted into USB and sealed the same in parcel no. 13. All the parcels were placed/affixed with a monogram of 'SH'. The complainant took into possession the recovered chars and the motorcycle Honda-125 having red colour, without registration number and tempered chassis vide recovery memo. The local police charged two unknown accused for the commission of offence. Murasila was drafted and sent to Police Station through constable Shabbir Khan for registration of FIR which was converted into FIR by Muqadar Khan ASHO.</p> <p>After registration of FIR, it was handed over to Investigation Officer, Aftab Hassan OII for investigation.
