The complainant recovered 04 packets of chars, wrapped with yellow colour

scotch tape, each weighing 1000 grams, making a total of 4000 grams of chars from a blue colour holding by the pillion passenger in his right hand.



Perusal of the case file reveals that neither the recovery has been effected from possession of the petitioner nor he has been charged in the instant case. At present there is no rival claimant.
