In present case accused petitioner has been directly charged in the instant case and specific role has been attributed to him. Recovery of axe has also been effected in the instant case and furthermore, medical report also support the complainant version. Furthermore, as per medical record available on the record the sense of hearing of complainant has also been lost due to the injury sustained over his head. Furthermore, the manner of commission of offence is also brutal in nature and is severe. The offence under section 336 PPC also fall within the prohibitory clause of section 497 Cr.P.C.</p>


