That in absence of father of the minors, she is entitled for her appointment as their guardian as she can take better care of the welfare.

- 5. There is nothing in rebuttal due to ex-parte and petitioner being real mother as she can take better care of the welfare of the minors than any other person. Therefore, she is appointed as guardian for person and property of the minors named above subject to the following conditions.
 - That she will maintain and educate the minors in proper manner.
 - That she will not take away the minors outside the jurisdiction of this court without prior permission.
 - That she will not act in prejudice to the interest of minors.
 - That she will not be entitled to dispose of the property of minors without prior permission of the court.
- 6. Petitioner has not submitted blank stamp paper and surety bonds, thus Original guardianship certificate be given to the petitioner subject to produce the blank stamp paper and surety bonds in the sum of Rs. 200,000/- with two local and reliable sureties each in the like amount
