

That you, while posted as priver to the Court of learned Additional District & Sessions Judge-II, Orakzai, have committed the acts of inefficiency, omission & negligence as below;

That pursuant to an explanation dated 27.08.2024 issued to you and yours written reply dated \$29.08.2024 which was found unsatisfactory, learned Additional District & Sessions Judge, Orakzai forwarded a complaint against you; accordingly following allegations are levelled against you as under;

- 1. You have absented yourself from duty on 27.08.2024 without application, intimation and permission.
- 2. You are also reportedly late comer despite warning.

- 1. You have absented yourself from duty on 27.08.2024 without application, intimation and permission.
- 2. You are also reportedly late comer despite warning.
- 2. In order to conduct regular inquiry about the above allegations against above named accused official, the learned Senior Civil Judge, Orakzai is appointed an inquiry officer in view of rule 10 (1) (a) of the *ibid* rules.
- 3. The inquiry officer shall, in accordance with the provisions of *ibid* rules, provide reasonable opportunity of hearing to accused official, record its findings and submit his report with recommendations as to punishment or other appropriate action against the accused official within 30 days of the initiation of inquiry.
- 4. Sayed Muhammad Razi Shah, the Superintendent to this office is nominated as representative of this office, who shall render full assistance to the inquiry officer during proceedings, where he shall be personally present and fully prepared with all the relevant record relating to the case, on each date of hearing to be fixed by the inquiry officer. He shall also cross-examine all the witnesses produced by accused official; may also cross-examine all the prosecution witnesses with prior permission of the inquiry officer and shall rebut the grounds of defense, if any, offered by accused official.



My statements are as under:

- 1. That I am serving in your respectable department as junior Clerk BPS-11 posted as Muharrir to Presiding Officers from starting till now.
- 2. That in my reply of explanation to Honorable Additional District and Sessions Judge Orakzai I have apologized and again I apology to worthy Senior Civil Judge Orakzai for not getting Casual Leave in advance dated 27/08/2024. Unfortunately Mobile Network /Signals of Whole District Hangu was stopped /crashed by Telecommunication Authority of KPK due the Chehlum Security purposes.
- 3. In my previous tenure I haven't made such mistake in attachment during duty to the respectable offices.
 - a. In December 2021 and Jan 2022 worked as Additional Muharrir to the Court of Worthy District and Sessions Judge Orakzai.
 - b. I worked as Additional Muharrir to the court of Honorable Additional District and Sessions Judge for some months.
 - c. Recently I was attached as Muharrir to the Respected Civil Judge/ Judicial Magistrate-1
 Orakzai.
 - Sir Alhamd-o-Lillah I worked with punctuality and timely regularizing myself with efficiency and no objection or explanation.
 - 4. Therefore it is humbly requested that unauthorized casual leave obtained and my please be pardoned as the first and last mistake of the official.
 - 5. Again special request of being kind to Local Civil Servant (Muharrir to AD&SJ Orakzai

 Muhammad Sabir Shah) as there is no other Authority of Forgiving and pardoning of the official as I am sincere, Earnest, Solemn and more Sincerer to Government and Governing Department of Equity and Justice.
 - 6. Sir it is hereby pointed to Worthy Senior Civil Judge Orakzai that in my siblings I am the elder one I have one other brother who is Senior Clerk at Tehsil Court Kalaya Residing and duty station are in Kalaya.

INQUIRY REPORT

Reference No. 7094-96/DSJ/ORK dated: 18-09-2024

Inquiry against accused official Muhammad Sabir Shah, Junior Clerk.

BACKGROUND:

On 27.08.2024 the learned Additional District & Sessions Judge, Orakzai sought an explanation from the accused official (Muhammad Sabir shah, Junior Clerk) on account of his absence from duty that day without intimation/permission/applying and approval of his casual leave application. In the light of reply of the accused official dated 29.08.2024, being unsatisfactory, the learned AD&SJ, Orakzai forwarded a report to Hon'ble District & Sessions Judge, Orakzai against the said accused official for initiation of legal proceedings. On 18.09.2024, the Hon'ble District & Sessions Judge, Orakzai, being Competent Authority, initiated disciplinary proceedings against the accused official by issuing statement of allegations and charge sheet dated 18.09.2024 and required him to submit his written reply within seven days after receipt of the said notice.

The undersigned was appointed as Inquiry Officer under Rule 05 of the Khyber Pakhtunkhwa Government Servants (E&D) Rules, 2011 in order to conduct regular inquiry into the charges levelled against the accused official with the directions to record findings and submit report to the Competent Authority within 30 days after initiation of the inquiry. The Superintendent to District & Sessions Judge, Orakzai was also appointed as Departmental Representative to assist the Inquiry Officer vide the same Office Order dated 18.09.2024.

After entrustment of the instant inquiry to the undersigned, on 19.09.2024, the ibid inquiry was registered in the relevant register and in response of already issued statement of allegations and charge sheet, a written reply of the accused official was sought for 23.09.2024. The accused official submitted his written reply on 26.09.2024 which was placed on file.

EVIDENCE: The accused official is charged mainly for two reasons: Firstly, for allegedly absenting himself from duty on 27.08.2024 without permission, and secondly, for coming late to the Office. These charges emanate from an explanation note issued to the accused official by learned AD&SJ, Orakzai. However, when accused/official submitted his written reply on 26.09.2024 and appeared before the undersigned, some mitigating circumstances came to the surface. In view of the written reply of the accused/official, which is self-explanatory, the undersigned considered it sufficient as the accused/official admitted his late coming to the Office/absence with noted reasons. Thus, there was no need to collect further evidence on the matter.

FINDINGS:

In view of the available documentary evidence, I am of the opinion that the charge of alleged absence by the accused official from his duty on 27.08.2024 seems true; however, as recorded in his written reply, the accused/official submitted that on the day of his absence on 27.08.2024, he could not make contact with Office due to suspension of mobile network services in Hangu area on account of security reasons during *Chehlum* processions and that he was attending his father who is suffering from Epilepsy. In addition, the accused/official admitted these facts with clean breast and sought sincere apology for his negligence and made a gentleman commitment not to repeat such behavior in future.

RECOMMENDATIONS:

1. As the charges against the accused/official could partially be proved, as evident from his admission, however, he has tendered his sincere apology for his omission and made a commitment that he would not repeat the mistake in future. Moreover, the accused/official has barely three-year service and hails from backward area who rely solely on this job for his sustenance. In view of the above cited background and facts, it is recommended that the apology of

accused/official, having barely three-year service, may be considered as he has made commitment for not repeating such mistake in future. It is recommended that a final warning may be issued to the accused/official who shall remain punctual and take utmost care of discipline in future.
