

Learned DPP for the state present.</p> <p>Accused/petitioner Attaullah S/O Najal Khan is seeking his post-arrest bail in case FIR No. 99, dated 08.10.2022, U/S 11-A CNSA of PS Kalaya, District Orakzai.</p> <p>Brief facts of the case are that complainant Mujahid Khan SI, NET has sent Murasila to the PS Kalaya through constable Yakoot Marjan No. 1064 wherein it is alleged that he was present at barricade on the main Mirbak Road on 08.10.2022, meanwhile at 11:00 hours a person was stopped in suspicious condition and during his body search, a white envelop containing 40 grams ICE was recovered from the side pocket of the accused which was weighed at the spot through digital scale. One gram was separated and packed and sealed into parcel No. 1 for sending the same for FSL and remaining 39 grams was sealed into parcel No. 2. The accused disclosed his name as Shah Muhammad S/O Khiyal Muhammad, Caste Malak Din Khel, R/O Lerri. The accused was arrested and the instant FIR was lodged by the local police of PS Kalaya against accused Shah Muhammad.</p>

The present accused/petitioner has been charged by the police in statement U/S 161 Cr. PC of the accused and he is not charged in the FIR. The case of the present/accused petitioner is one of further inquiry and he is thus held entitle to the concession of bail. He be released on bail subject to furnishing bail bonds worth Rs. 100,000/-with two sureties each in the like amount to the satisfaction of this court.
