



Arguments heard and record perused.</p> <p>Accused/petitioner namely Mehtab Ali Son of Ayaz Ali, resident of Qom Bar Muhammad Khel, District Orakzai is seeking his post arrest bail in case FIR No. 78, dated:14.08.2024 under sections 11-A CNSA & 15AA, PS Kalaya, Orakzai.</p> <p>Perusal of record would reveals that accused/petitioner is directly and by name charged under section 15AA for possessing 30 bore pistol bearing no. 3105886 along with a fixed charger containing 07 live rounds of the same bore and under section 11-A CNSA for possessing 45-gram methamphetamine (ICE). Recovery has been effected from direct possession of the accused/petitioner. The offence U/S 11-A CNSA is heinous in nature and affects the society at large. Although, the offence for which accused/petitioner is charged does not fall within the ambit of prohibitory clause of Section 497 Cr. PC but this fact by itself will not create a right in favor of accused/petitioner for grant of bail as there is sufficient material available on record connecting the accused/petitioner with the</p>


