


Order No.05</p>		<p>constructing a room on their property where at about 09:00 am the present accused/petitioners with co-accused and three unidentified accused arrived there, attacked the complainant and his father, criminally intimidated them by making aerial firing, forcibly took 02 lac rupees from the complainant's father and abducted him. Hence, the instant FIR.</p> <p>Arguments heard and record gone through.</p> <p>Perusal of the case file reveals that the accused/petitioners are directly nominated in the FIR. Counsel for the accused/petitioners failed to point out any malafidi or ulterior motive on behalf of police or the complainant for falsely implicating the accused/petitioners in the instant case. In these circumstances, the accused/petitioners are not entitled to the extraordinary concession of bail, hence the instant BBA petition is dismissed and ad-interim bail earlier granted to the accused/petitioners vide order 30.09.2024 is recalled.</p> <p>Order announced. File of this court be consigned to record room after its necessary completion and compilation. Copy of this order be placed on police/judicial file.</p>
