



Record already received.</p> <p>The accused/petitioner namely Khayal Shah son of Yaqoob Shah, resident of Qom Mishti, Tappa Mamizai, Mishti Chappar, Anjghalay, Orakzai has applied for his post arrest bail in connection with case FIR No. 13, dated: 31.03.2024 under sections 506/427/34 Pakistan Panel Code & 15-AA, registered in PS Central Mishti Mela District Orakzai.</p> <p>Counsel for accused/petitioner had already submitted written arguments in the instant bail petition while learned APP advanced arguments.</p> <p>The offence with which accused/petitioner is charged does not fall within the ambit of prohibitory clause of Section 497 Cr.PC. In such like cases grant of bail is a rule and refusal are an exception. Furthermore, no recovery regarding the weapon of offence has been affected in the instant case from the present accused/petitioner. Furthermore, one of the accused in the instant case has been released, hence, role of consistency apply to the case of accused/petitioner. Accused has not confessed his guilt before the court. Investigation has already been completed and accused/petitioner is no more required to the local police for further investigation and no useful purpose would be served by keeping the accused/petitioner behind the bar.</p> <p>In given circumstances, this court is of the view that role of ineffective firing has been attributed to all the accused and</p>
