

Written arguments on behalf of accused/petitioner submitted.</p> <p>The accused/petitioner namely Muhammad Ashraf son of Chinar Gul, resident of Qom Malla Khel, Tappa Char Khela, Tehsil Lower District Orakzai is seeking his post arrest bail in Case FIR No.19 dated: 20.10.2024 under sections under sections 324, 148, 149 PPC, Police Station Daboori, District Orakzai.</p> <p>Although, accused/petitioner is directly and by name charged in the FIR by complainant of PS Daboori and the punishment for the offence U/S 324 PPC falls within the ambit of prohibitory clause of Section 497 Cr. PC, however, record shows that accused/petitioner along with co-accused is nominated in the FIR by complainant without disclosing any source of information regarding involvement of the accused in the commission of the offence. There was cross firing between the parties but none of the party (nominated accused) have charged anyone for the commission of the offence. Accused has not been arrested at the spot. Nothing incriminating has been recovered from possession of the present accused/petitioner. No eye witness is mentioned in the FIR. No injury sheet or medical report is attached, which means that it is case of non-effective firing for intimidation. Therefore, it is case of further inquiry. Moreover, investigation has already been completed and accused is no more required to the local police for further investigation and no useful purpose would be served by keeping the</p>


