## SUMMARY JUDGEMENT 14.10.2024

Plaintiffs through attorney alongwith counsel present. Representative of defendants present. Authority letter and written statement already filed. Today, the case was fixed for framing of issues, however, representative of defendants stated that per record, there is unnatural age gap of 10 and 12 years between plaintiffs with their son namely Naiz Wali, therefore, if suit of plaintiffs is disposed

of through summary judgement, he has got no objection. Arguments heard and record gone through.

Brief facts in the backdrop are that plaintiffs have filed the instant suit for declaration cum-permanent injunction to the effect that, true and correct date of birth of plaintiff No.1 is 01.01.1964 and plaintiff No.2 is 01.01.1965 however, defendants have incorrectly entered the same as 1971 and 01.01.1973 which entries are wrong, illegal and ineffective upon the rights of plaintiffs and liable to be rectified. That due to this wrong entry, there is exist an unnatural gap of about 10 and 12 years between the ages of plaintiffs and their son namely Niaz Wali whose date of birth is 07.12.1983. That defendants were asked time and again to rectify date of birth of plaintiffs but in vain hence, the present suit.

With due process of law and procedure, the defendants were summoned, they appeared through representative. Authority letter was submitted. Written statement was also filed.

Representative of defendants stated that there shall be at least 16/17 years' age difference between parents with their son. Per record, date of birth of plaintiff No.1 is recorded as 01.01.1994 and

correct date of birth of plaintiff No.2 is 01.01.19971 while date of birth of plaintiff's son namely Niaz Wali is recorded as 07.12.1983 resulting into unnatural age gap of about 10 and 12 years. Plaintiffs are not a government servant. The modification sought by plaintiffs will not affect rights of others. Representative of defendants stated that date of birth of plaintiffs may be modified as per NADRA SOPs. There is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff No.1 as 01.01.1994 and plaintiff No.2 as 01.01.19971. Suit of plaintiffs is decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any. This decree shall not affect service record of plaintiff, if any.
