Record already before the Court.</p> <p>Accused/petitioner namely Noor Asif Khan son of Said Marjan, resident of Qom Feroz Khel, Tehsil Lower District Orakzai, seek his post arrest bail in case FIR No. 31 dated 04.04.2023 under sections 392 PPC, 5 Exp. Substance act and 15AA Police Station Kalaya, District Orakzai.</p> <p>Arguments heard and record perused.</p> <p>Perusal of the record reveals that although the accused/petitioner is by name nominated in the statements recorded under section 164 Cr. PC by Jehad Ullah and Imran Khan for the commission of offence. Although the offences fall within the ambit of prohibitory clause of 497 Cr. PC, however, nothing incriminating has been recovered from the possession of present accused/petitioner. No specific role assigned to the present accused/petitioner. Additionally, the present accused/petitioner is neither charged in the FIR nor arrested on at the spot. Moreover, the co-accused have already been granted bail, hence, rule of consistency also applies to the case of accused/petitioner. The investigation in the instant case is complete and no better purpose will be served if the accused/petitioner is kept in jail in the existence of above-mentioned circumstances.</p> <p>Consequently, the bail petition in hand is allowed. Accused/petitioner is ordered to be released on bail subject to furnishing of bail bonds to the tune of Rs: 100,000/- (one</p> |
